REQUIREMENTS FOR PARTICIPATION

To take part in the conference, the **Article** and **application** form in separate files should be sent to mbd_konf_2022@mail.ru. The Article and application form should be named after the name of the first author (Ivanov_Moscow). More details in Appendices 1, 2.:

- In the subject line indicate: "Article [Author's name]".
- The collection of the conference with publishing in the RSCI will be sent out in electronic form
- Published work must be carefully edited and contain original material. Articles are published in the author's edition.
- All articles are checked for plagiarism (the originality of the text is not less than 70%).

REQUIREMENTS TO ARTICLES FOR INDEXING IN DATABASES SCOPUS/WEB OF SCIENCE

- Maximal amount of authors for one article not more than five
- Each participant can submit a maximum of two articles.
- The volume of the article: from 12 000 characters (including bibliography).
- Accepted for consideration manuscripts of articles that are written in English, as well as in Russian
 - Article format: solely doc and docx.
- Presented text of the manuscript should strictly comply with the Conference issue and reflect the results of theoretical and experimental research.
- Graphic images should be translated into English (if the manuscript is presented in English) or be presented in an editable format (if the manuscript is presented in Russian).
- The article must have the following sections: "Introduction", "Methodology", "Results", "Discussion", "Conclusions", "Bibliography". Information considering financial support is indicated in the section "Credits" or "Conclusions".
- If original statistical data were used in the research, then the authors must provide replication data (questionnaires, research protocols, collected and raw statistical data in any form), which will be published along with the article.
- The in-text references to the literature and the list of references itself should be formatted according to APA standard. It is recommended to use high-quality foreign scientific literature published in reliable scientific journals (indexed in the databases "Scopus", "Web of Science"). The list of sources should contain no more than 10% of the sources, the author/co-author of which is the author of the submitted article.
 - A sample of an article in Appendix 3.

ORIGINALITY AND PLAGIARISM

Articles should be completely original works that have not been published anywhere before. When using the work of others, it should be appropriately cited. The originality of the text should be at least 80%. The Organizing Committee reserves the right to refuse publication of the manuscript at any stage if the fact of plagiarism or republication of the already accepted text of the manuscript of a scientific article in other scientific publications is discovered. In this case, the paid registration fee will not be refunded.

Publication in the collection of materials of the conference is paid and amounts to 25,000 rubbles if the manuscript of the scientific article is presented in English, which does not require professional proofreading. Additional services are also provided: translation of the text of the manuscript of a scientific article into English: 850 rubbles / 1800 characters with spaces (translation into English is carried out by professional translators).

Abstract. You should leave 8 mm of space above the abstract and 10 mm after the abstract. The heading Abstract should be typed in bold 9-point Arial. The body of the abstract should be typed in normal 9-point Times in a single paragraph, immediately following the heading. The text should be set to 1 line spacing. The abstract should be centred across the page, indented 17 mm from the left and right page margins and justified. It should not normally exceed 200 words.

Keywords. 3-6 keywords

1 Page layout

Use 170×250 mm paper size (W x H mm) and adjust the margins to those shown in the Table 1. The final printed area will be 130×210 mm. Do not add any page numbers.

1.1 Formatting the title, authors and affiliations

1.1.1 Formatting the title

The title is set in bold 16-point Arial, justified. The first letter of the title should be capitalised with the rest in lower case. You should leave 22 mm of space above the title and 6 mm after the title.

1.1.2 Formatting author names and author affiliations

The style for the names is First Names, typed in italic 10-point Times, then Last Name, typed in 10-point Times, with a comma after all except the last author, which is separated by comma + "and". Do not use academic titles.

Affiliations of authors should be typed in 9-point Times. They should be preceded by a numerical superscript corresponding to the same superscript after the name of the author concerned. Please ensure that affiliations are as full and complete as possible and include the country.

1.2 Formatting the text

The text of your paper should be formatted as follows:

- 10-point Times, Times Roman or Times New Roman.
- The text should be set to single line spacing.
- Paragraphs should be justified.

- The first paragraph after a section or subsection should not be indented; subsequent paragraphs should be indented by 5 mm.

The use of sections to divide the text of the paper is optional and left as a decision for the author. Where the author wishes to divide the paper into sections the formatting shown in Table 2 should be used.

2 Figures and tables

Figures and tables, as originals of good quality and well contrasted, are to be in their final form, ready for reproduction, pasted in the appropriate place in the text. Try to ensure that the size of the text in your figures is approximately the same size as the main text (10 point). Try to ensure that lines are no thinner than 0.25 point.

2.1 Captions/numbering


Captions should be typed in 9-point Times. They should be centred above the tables and flush left beneath the figures.

2.2 Positioning

Place the figure as close as possible after the point where it is first referenced in the text. If there is a large number of figures and tables, it might be necessary to place some before their text citation.

2.3 Colour illustrations



You are free to use colour illustrations for the online version of the proceedings, but any print version will be printed in black and white unless special arrangements have been made with the conference organiser. Please check whether or not this is the case. If the print version will be black and white only, you should check your figure captions carefully and remove any reference to colour in the illustration and text. In addition, some colour figures will degrade or suffer loss of information when converted to black and white, and this should be considered when preparing them.

3 Equations and mathematics

Equations should be centred and should be numbered with the number on the right-hand side.

Use italics for variables (u) and bold (\mathbf{u}) for vectors. The order for brackets should be $\{[()]\}$, except where brackets have special significance.

The acknowledgements should be typed in 9-point Times, without title.

References

Online references will be linked to their original source, only if possible. To enable this linking extra care should be taken when preparing reference lists.

References should be cited in the text by placing sequential numbers in brackets (for example, [1], [2, 5, 7], [8-10]). They should be numbered in the order in which they are cited. A complete reference should provide enough information to locate the article. References to printed journal articles should typically contain:

- The authors, in the form: initials of the first names followed by last name (only the first letter capitalized with full stops after the initials),
 - The journal title (abbreviated),
 - The volume number (bold type),
 - The article number or the page numbers,
 - The year of publication (in brackets).

Authors should use the forms shown in Table 3 in the final reference list.
